- (3) to vote FOR , or AGAINST or, if no specification is made, vote FOR the resolution to approve the amendment to the Corporation's stock option plan as set out in Schedule "A" to the Circular; and
- (4) to exercise discretionary authority to vote on amendments or variations to the matters identified in the notice of the Meeting and on all other business as may properly come before the Meeting or any adjournments;
